Vice President: Lesley Hammar report. We have moved our Specialty date to Thursday, December 15th 2022. And we have worked with the club and will be adding sweepstakes. She is updating our contract with the Breeder Judge, Yolanda Lininger. And asked Cathy Donovan who is a member of our club and the PWCCA, to judge sweepstakes. Treasurer: Gail Steinmetz – Bank statement reconciliation through January 31st, \$26,589.48, less \$61.25 for the annual report. We did a supported entry for the January Brooksville shows and they sent us \$24. The three clubs with our show in December paid us between \$120-\$155 for that supported entry. The Central Florida club that we will be going with will be paying us \$5 a dog and picking up a couple of nights for our judge and some misc things. We won't have any superintendent; we will be using their ring steward (we think but we will double check). They won't let us be a



concurrent but the advantage to that, being a designated is that we are not limited to the number of dogs we can have.

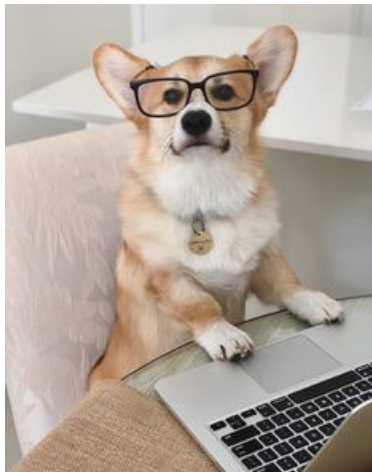
