## In Memoriam



### MY FRIEND, KAY McLAIN KATHRYN JOHANNA MARGRETHE BOISEN OUTZEN McLAIN 10-28-1926 TO 2-11-2022

Many years ago, my husband Bill and I had two Old English Sheepdogs and a Briard, all three of whom suffered from either hip dysplasia or osteochondritis. When we lost the last one, our friend Sue Hamlin said to us, "I know you like the herding breeds. I think you need a corgi." And off she took us to meet her dear friend Kay McLain at Royal Mark Kennel in Ithaca, New York. Within a very short period of time we were living with four corgis and were enchanted with the breed.

One night, after Kay had cooked a particularly delicious dinner, she took Bill to the kennel, and there he saw Royal Mark Sea Master, who had accumulated three majors and 14 points, only to go "ring sour." Bill was smitten. We bought Master with the proviso that he remain registered in Kay and Neil's names until he won that last elusive point. Off we went to every show within reasonable driving distance - 23 in all, over the course of a year. Neil showed him, Kay showed him, I showed him, and we even hired Peter Green to show him several times, but Master would lie down in the ring and refuse to get up. We entered him in three shows in Cleveland, where old-time handler George Rood showed him. Master went reserve on the first day - progress! The second





day at Western Reserve was blisteringly hot and dry, and the judge had George move Master diagonally across some fairly tall grass. Master hopped a bit, and the judge said to George, "He's feeling frisky today, " and George replied, "Yes, sir, but I'll try to hold him back." Kay and I, holding our collective breaths, stood several rings away. Master won the open class and went on to take the points. By this time, he had acquired quite a claque of people cheering him on. The drive home was much shorter than the drive to Cleveland had been. On the following day, Master spit out one of his canines - just in case we had any thoughts of specialing him. By this time he was five, and he had finally earned his retirement.

Kay loved to sail, and we boated with her often on Seneca Lake. Bill and I were both musicians, and Kay and Neil came to nearly every concert in which we performed. We enjoyed many wonderful times together. And Bill and I loved living with our four wonderful Royal Mark corgis.

Kay was always extremely proud of her Danish heritage. Her mother emigrated from Denmark when she was 19 and was always proud that she traveled second class. Early on, after Kay and her two brothers were born, all three children were sent to Denmark to live with grandparents while their mother built her career working in New York City. Kay returned to Denmark often throughout her life and was always proud when people commented that she spoke Danish just like Queen Margarethe. I traveled to Denmark with Kay and her family, and with their Danish relatives embarked on a trip to Norway. During that time, they all seemed to have forgotten that they spoke English, and I never knew where we were or what time dinner would occur. It was truly an experience!

In 1999 we were down to only one corgi, Royal Mark Rosenquest (Annie Rose). Bill and I retired, sold our home, and moved aboard our sailboat with Annie Rose. We cruised for a year and eventually settled in Fort Myers, Florida. Kay and her brother and sister-in-law, George and Polly Outzen, came to Florida and eventually decided to build homes here. More good times ensued.

Kay and I always attended the Sunshine Pembroke Welsh Corgi Club Specialty shows here in Florida. At the first meeting Kay attended, she stood up to introduce herself. Gail Steinmetz said to her, "Oh, for heaven's sake,





Kay, everybody knows who you are, and we are thrilled to have you join us."

Kay was an accomplished cook, and one of her specialties was the Danish birthday cake - 4 layers of white cake with alternate fillings of raspberry jam and whipped cream, which also served as the frosting. Whenever we attended a dog show, if Kay was aware that one of her friends was celebrating a birthday, she would bake the cake, and it would be transported in a cooler to the show. Many years later I was aghast to learn that the actual cake was made from a mix!

Fast forward to my birthday several years later. Our mutual friend Sue Hamlin, also an accomplished cook, came to Florida for a visit and offered to prepare my birthday dinner, to which Kay and her family were of course invited. For many years Kay had always asked me what kind of cake I wanted for my birthday, and I always responded that I would like a chocolate cake with chocolate frosting. But somehow, the Danish birthday cake would always appear. Sue, however, was happy to bake me a chocolate cake with chocolate frosting. After Sue's return home, Kay told me that she could bake a much better chocolate cake than Sue had, and from that time on I had chocolate cake on my birthday.

Kay's health began to fail, and she fell and shattered a femur, necessitating a lengthy visit in a rehabilitation facility. It became increasingly difficult for her to care for her two corgis, and we arranged to send the male to her son, who was living in Oregon. Our mutual friends, the Handshaws, took in her second corgi, Pippin, who lived with them in North Carolina for many years.

The last of the Royal Mark corgis are gone, but I treasure the memories of our times with the McLains and the corgis who enriched Bill's and my lives. Annie Rose, our last Royal Mark corgi, became my first registered therapy dog and Reading Education Assistance Dog, and our visits to schools and libraries were truly rewarding.

Thank you, Kay. I salute you for a life well lived.
