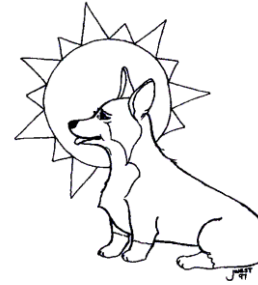

In the event of a tied score, the Corgi with the fastest time for their class (i.e., ran the lowest percent of standard class time; e.g., ran 50 secs/60 secs std course time = 83.3%) will be considered HIT.

NOTICE TO EXHIBITORS

THE SAFETY OF DOGS is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

THE TRIAL WILL BE OPEN each day from 6:00 a.m. to 8:00 p.m.

RETURNED CHECKS do not constitute a valid entry fee. A charge of \$25.00 will be made for each returned check for either club.

TELEPHONE, EMAILED, FAXED, INCOMPLETE AND UNSIGNED ENTRIES cannot be accepted.

ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES OF ENTRY FORMS without the Agreement and Rules on the reverse side of the Official AKC Entry Form are **NOT ACCEPTABLE**. **Unsigned entries or entries missing information will be returned.**

ENTRIES RECEIVED WITHOUT FEES will not be accepted. **Entry fee:** \$22.00 first class each dog each day (includes \$3.50 AKC recording fee for first entry and \$3.00 entry for every additional run) \$13.00 additional class, same dog, same day
Jr Handlers REDUCED FEE FOR DTCSP (Fri, Sat & Sun) ONLY (under 18 at time of trial, AKC Jr #, running dog owned by self or immediate family member) reduced entry fees will be \$18 first entry, \$10 2nd/3rd for same dog, same day (still includes same recording fees).

Checks payable to SPWCC (Thurs & Fri) or DTCSP (Sat, Sun & Mon)

TWO ENTRY FORMS, TWO CHECKS mailed together (IF ENTERING ALL FIVE DAYS)

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE. Express mail entries must include signature permitting them to be left at the secretary's address without recipient's signature.

ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Trial Committee. If because of extreme weather, riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or to complete the trial, no refund of entry fees will be made.

ERRORS ON ENTRY BLANKS Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in event of such errors or cancellation of entries after trial has closed

(IF YOUR DOG HAS AN AKC NUMBER (not ILP) YOU NEED TO FILL OUT THE BREEDER, SIRE & DAM INFO ON THE ENTRY FORM ALSO.)

BITCHES IN SEASON are not eligible to participate. There will be a refund of entries due to bitches which come in season after trial has closed, provided that the owner gives notice in writing to the trial secretary **no later than one half hour prior to the start of the first class of the day of the trial**. Subject to \$5.00 fee per class.

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. The owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. If handlers have a ring conflict and so inform the gate steward, every effort will be made to accommodate you.

TRIAL COMMITTEE WILL NOT BE RESPONSIBLE for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

ALL DOGS MUST BE ON LEASH AT ALL TIMES EXCEPT WHEN IN THE RING OR IN THE DESIGNATED WARM-UP AREA. Exhibitors are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior, may, at the discretion of the trial committee, be asked to leave the show site. In such cases, no refund of any fees will be made. All dogs present must be held on leash or confined to their crates at all times except when in the ring or when in the designated agility warm-up area. **All exhibitors must pick up dog waste everywhere on the show grounds.** The site will be monitored and offenders will be asked to leave. In such cases, no refunds will be made.

MOVE-UPS: Dogs may be moved up at the request of the owner as a result of qualifying for an agility title, provided that the request is made to **the Trial Secretary in writing**. (E-Mail is acceptable.) All move-ups for the weekend must be received by the trial secretary no later than **Monday, December 24, 2018 at 6PM**. Day to day move-ups will be accepted over the weekend..

ELECTRONIC TIMERS will be used for all classes

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds. Bitches in season, aggressive, blind dogs or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance are ineligible to participate.

OBSTACLES: Obstacles will be used as described in the most current American Kennel Club Regulations for Agility Trials rulebook.

HEIGHT DIVISIONS:

Exhibitors are responsible for entering the proper height divisions. In the Regular classes, dogs may be entered at the jump height for which their measurement qualifies them or a higher jump height, if the exhibitor chooses. In the Preferred classes, however, dogs must run in the jump height for which their actual measurement qualifies them.

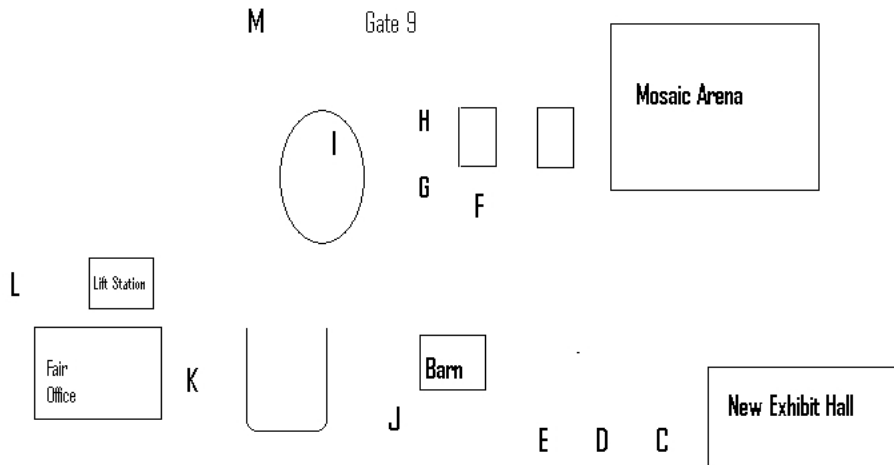

AGREEMENT

I (we) agree that the club holding this event has the right to refuse entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend, and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTREPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. INSTRUCTIONS

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box. Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?

I CERTIFY that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of the American Kennel Club in effect at the time of this event, and by any additional rules and regulations appearing in the premium list for this event, and further agree to be bound by the "Agreement" printed on the reverse side of this entry form. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. This entry is submitted for acceptance on the forgoing representation and agreement.
