# Treasurer's Report



October 7, 2022 checking account balance was \$28,983.93. We are very fortunate to have a very generous membership to help with donations both for agility and conformation events. We do need that to continue for our future events.

## **Judge Selection process**

The Board is working on judges for our future shows. They will present to the membership a list of five names for Breed and 3 names for Sweepstakes for our 2024 July Specialty in Ocala, FL.

If you have any judges or corgi breeders you would like us to consider, please see the criteria below and submit their names to any board member. We can add names as submitted, or if you know a judge is no longer judging or deceased, please let us know that as well.

#### Criteria

Breed Judge

- 1. Must be licensed to judge PWC
- 2. Must have owned/co-owned PWC for at least 10 years
- 3. Must have bred/co-bred four litters of PWC and finished at least 2 champions of their breeding.
- 4. Must have attended 4 PWC Specialties or their equivalent, in the case of a foreign judge, in the last 10 years.

- 5. OR Must be eligible to judge all AKC breeds and groups.
- 6. AND must agree to only charge expenses.

NOTE\*\* After the 2017 Specialty in Orlando and the AKC rule that Sweepstakes could not be held on the Specialty Day, the board voted to stop Sweepstakes until we are able to host an independent specialty or AKC allows it on our show date. This was announced to the membership at the April 7, 2018, meeting and in the April 2018 newsletter.

- \*\*Ratified at the 10/11/2022 zoom board meeting to hold sweepstakes at future shows. Sweeps Judge
- 1. Must have been involved in the breed for at least 10 years
- 2. Must have bred/co-bred four litters of PWC and finished at least 2 champions of their breeding.
- 3. Must have attended 4 PWC Specialties in the last 10 years.
- 4. Must hold membership in an all-breed or PWC specialty club

## **August 2022 Agility Trial**

This year's SPWCC Agility Trial started out on rough ground but went very smooth. Trial chair Bonnie Hansen ended up with Covid right before the trial and passed the duties on to fill in trial chair Alisha Stevenson. With the diligent help of Gail Steinmetz, Lesley Hammar, and Sharon Lofley the trial went on with no complaints. We had a lot of volunteer help from the exhibitors which ensured all the working spaces were filled and the trial was completed both days early. Our judge for the second year Christine Bishop gave us great courses and an upbeat agility trial. Three of our club members trialed their dogs this year. Lesley Hammar with Rachel, Alisha Stevenson with Dobby, and Bonnie Hansen (fill in handlers) with Magic. High in Trial Regular going to Lesley and Rachel. High in Trial Preferred going to Alisha and Dobby. Thank you to everyone that made this trial happen and congratulations to all the handlers and their dogs.

This year's agility trial was indeed a "trial".

At the last minute, three of our committee were unable to attend due to covid-19 positive or exposure including Bonnie Hansen our trial chair, leaving Alisha Stevenson to step up and learn on the job. She did a fantastic job holding the trial together. Thank you to Sharon Lofley who came over on Sunday to help our meager crew of Alisha Stevenson, Lesley Hammar and Gail Steinmetz.

This year's trial had entry fees of \$8,541.00, member supported donations of \$392.52 and one vendor for \$40.00 for a total income of \$8,973.52. Expenses for the site \$1972.00, AKC fees \$1958.50, Judge fee/expenses \$1271.47, trial secretary \$650.00 (she gives us a very big discount) and workers raffle/meals \$424.52 for a total expense of \$6,276.49 leaving us a profit of \$2,697.03.

At the 10/11/2022 Zoom general meeting the membership voted unanimously to stop (for the near future) holding agility trials. We had discussion as to other options and events we can consider depending on membership involvement.
