From the Editors

Morgan Humphrey & Sir Cedric

As some of you may know, Sir Cedric the Fluffy is certified as a therapy dog under Pet Partners. Usually, we work in assisted living facilities with residents with memory issues. The pandemic really limited our work, but we've finally begun to get back into facilities. However, as tragic as the pandemic was, it increased accessibility in many regards, even opening opportunities to visit in locations we couldn't previously. Recently, we've begun working with an ESE group in public school virtually. Yes, Cedric learned how to Zoom and did therapy work for children in Florida, despite currently living in Texas. Activities change every time we do this work. For example, in our first meeting, we introduced ourselves and our dogs, and had them wave to the kids on Zoom. We then had the dogs do tricks, including classics like "Shake" and "Roll Over". Finally, the children asked us questions about therapy work and dog training. Primarily, we talked about how important the handler-dog relationship is, and how the handlers have to constantly be monitoring and interpreting their dog's needs. Handlers need to recognize potentially stressful situations before they occur and navigate out of them or work with the dog on handling the situation. One of the techniques used to interact with your dog in tense situations is PETS: Presence, Eye Contact, Touch, and Speech. All handlers have to know and understand that we are our animal's best advocate. Incredibly, by using Zoom and other virtual platforms to provide animal-assisted therapy, we can enter more complex and challenging environments without placing additional stressors on the dogs. We are excited to see how this program grows and develops with us, as well as watch new opportunities come to light within the dog world.
