During the past month, Canny, Dan, and I have participated in a "Nose Work Skills Challenge." The National Association of Canine Scent Work (NACSW) developed a protocol for members and their dogs to demonstrate a variety of skills. Over 750 human/dog teams participated in the challenge, with an option of 3 levels of challenge for each of 8 skills.

Each skill was judged and then awarded points.

During this downtime, the Challenge was an opportunity for NACSW to research dogs' abilities; the results could provide NACSW trial leaders guidance when setting odor hides at trials at various levels of competition.

Dan and I had a great time playing with Canny on this 4-week Skills Challenge.

Dan's camera work and Canny's nose rock!

Canny had a blast, and we were very proud of him as he demonstrated skills that he'd never tried before.

Bottom line, Canny earned the maximum score, so he achieved a "Skills Master" designation (along with 313 other teams - 50 got Level 1; 161 Level 2; 186 Level 3, and 44 incomplete!)
