## JUDGE SUGGESTIONS NEEDED

In January each year, requests for judge suggestions for the Annual Specialty will be solicited from the membership. The Board will vote on these suggestions by secret ballot. The top 5 names for breed judge and the top 3 names for sweepstakes judge will be sent to the Vice President, who will make an invitation to the top vote-getter for breed and sweepstakes judge.

### **Breed Judge**

1. Must be licensed to judge PWC.
2. Must have owned/co-owned PWC for at least 10 years.
3. Must have bred/co-bred four litters of PWC and finished at least 2 champions of their breeding.
4. Must have attended 4 PWC Specialties or their equivalent.

**-OR-**

If not a Pembroke Welsh Corgi Breeder, must be eligible to judge all AKC breeds and groups.

### **Sweepstakes Judge**

1. Must have been involved in the breed for at least 5 years.
1. Must have bred/co-bred four litters of PWC and finished at least 2 champions of their breeding.
2. Must have attended 2 PWC Specialties in the last 5 years.
3. Must hold membership in an all-breed or PWC specialty club.

Submit your judge suggestion to a member of the board.

### December AKC Update to Clubs

#### **OPPORTUNITIES FOR MAJORS AT SPECIALTIES STARTING JULY 3, 2024**

A modification to Chapter 16, Section 1 of the [AKC Rules Applying to Dog Shows](#) was approved by the Delegate body at their December meeting. The modification provides all specialty clubs the option for the Reserve Winners Dog and Reserve Winners Bitch to earn a three-point major provided that the number of dogs competing in the regular classes of the Reserve Winner's sex totals at least twice the number required for a five-point major, in the region in which the event is held. Previously this option was only available at a breed's National Specialty. Clubs must opt-out on their event application if they do not want this option available at their specialty show. This option is available for events held on or after July 3, 2024.



## December AKC Update to Clubs (cont'd)

### JUDGING SWEEPSTAKES, FUTURITIES, AND SPECIAL ATTRACTIONS AND EXHIBITING

A clarification has been added to Chapter 11, Section 13 of the [AKC Rules Applying to Dog Shows](#). The clarification is: “*Judges of sweepstakes and futurities, and all other special attractions held with a conformation show should refer to the [Rules, Policies and Guidelines for Conformation Dog Show Judges](#) for any applicable exhibiting restrictions as they are defined by Board policy.*”

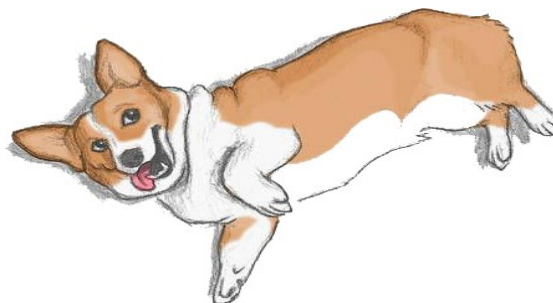
### CONFORMATION APPLICATIONS AND PANELS DUE AT LEAST 18 WEEKS PRIOR TO CLOSING

As a reminder, event applications and judges panels for Conformation shows must be submitted at least eighteen (18) weeks prior to the closing of entries. So that they comply with the rules, we recommend that clubs set a goal to submit their applications and panels six months prior to the date of their event. This will provide ample time for the processing of the applications and panels and the resolution of anything needed for approval.

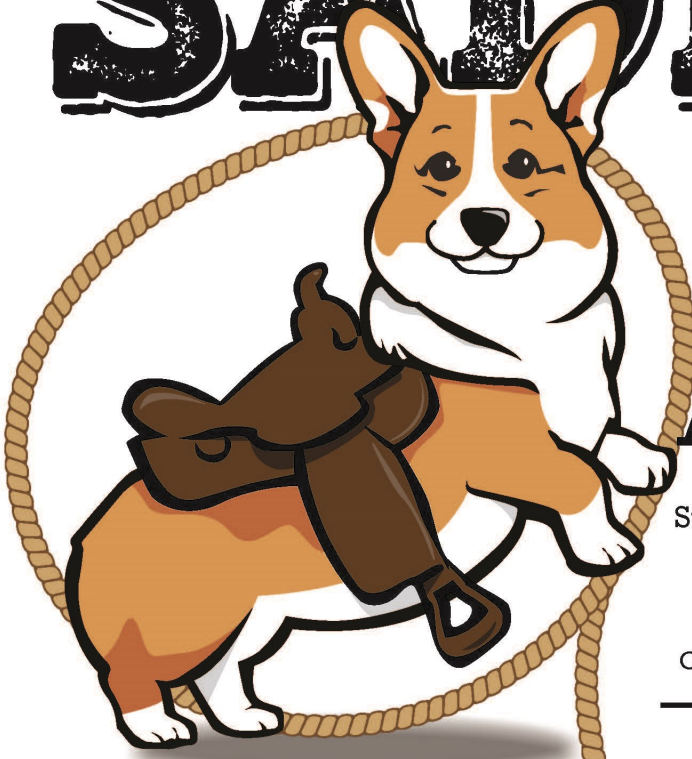

### Maggi's Magical Moment

My dear long-time friend Maggi Payne died of ovarian cancer on Tuesday, October 18, 2022, in Ft. Myers, Florida. Maggi and I had had a good phone visit the previous Saturday when she told me she was going into Hospice the next day, and her only regret was having to give up her Golden Retriever, Nova, to her friend, Fred.

Her niece and executor, Andrea Wilson, was with Maggi when she passed and let me know of Maggi's passing and when her funeral was to be held (at the First Congregational Church of Cape Coral). I attended the December 3<sup>rd</sup> service remotely.

Staying in touch with Andrea helped to get the spreading of Maggi's ashes planned. Knowing that Maggi was a very well-organized person, to the point where she left instructions that her ashes were to be spread in water. Andrea asked for my assistance, and I suggested Seneca Lake, as that is where Maggi and Bill had begun their sailing adventures. I contacted Geoff Terwilliger of Finger Lakes Watersports to get information and subsequently rented one of Geoff's boats for 1 PM on Thursday, September 7<sup>th</sup>.

I asked Andrea if she thought having a Congregational minister might be appropriate, since Maggi had always referred to herself as a "cradle Congregationalist" having attended Park (Congregational) Church in Elmira all her life until she and Bill moved to Florida. Andrea thought that was a good idea. I had recently met Beth Frigard, an ordained Congregational minister (and my friend Suzy Smith's cousin) at a gathering at Suzy's house. I called Beth and explained what we needed, and she was immediately "on board."

A little later, Beth phoned and suggested we have petals to strew after the ashes. Great idea, I said, and remembering that Bill always bought yellow roses for Maggi, agreed to get the roses.

We boarded the boat at 1 pm – and Geoff asked where we wanted to go. I suggested that we should go 8 miles north on Seneca, since both Maggi's and Bill's birthdates have been on the 8<sup>th</sup> - of January and June respectively.

And so, the trip began.

We passengers, Andrea and Steve Wilson, Maggi's cousin Terry Weida from Bethlehem, PA, Rev. Beth Frigard, and I shared our memories of Maggi, and what a wonderful special person she was. Talking about Maggi was interspersed with readings from Beth.

Geoff informed us when we had gone 8 nautical miles, and as Andrea commenced scattering Maggi's ashes, we all heard a single clap of thunder from the west as each of us began scattering yellow rose petals on the water. When all the petals were gone, as we were heading back toward Watkins Glen, the most incredible and wonderful thing occurred. A single seagull flew and circled the area where the petals covered the water. The seagull circled twice more and then dove toward the water and picked up one of the petals and flew off. We were all amazed at what we had just heard and seen. It's as though Maggi were with us and saying "OK, well done."

I'm still in awe of what happened. It was truly Maggi's magical moment.

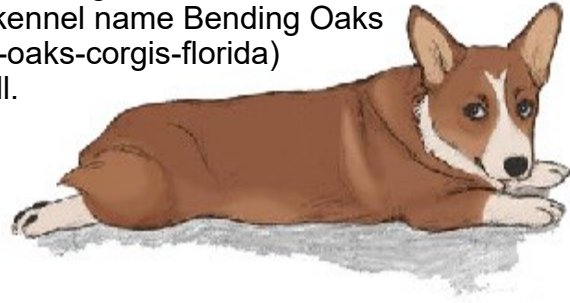




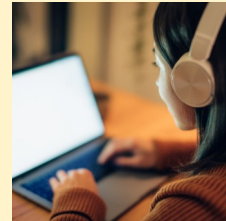
# New Member Welcome
