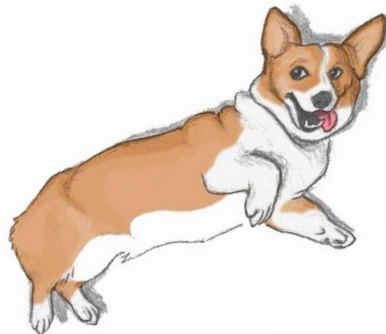
Big news about our next specialty coming soon!! I'm not sure about all of you but I am ready for some cooler weather ... and best of all the fall show season!

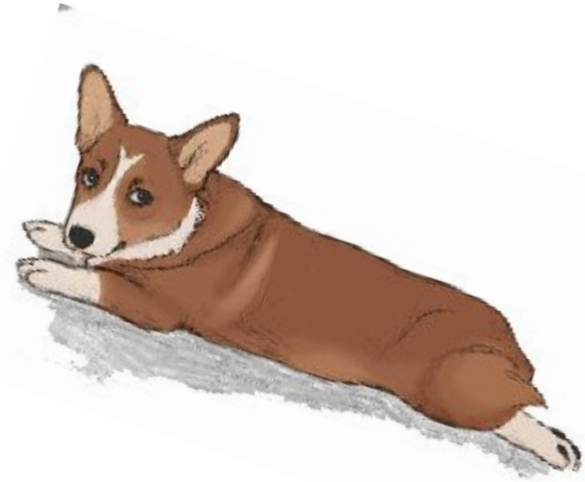

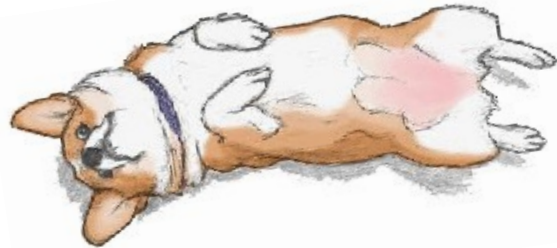
